

# **FICO® Score Summary Terms and Conditions**

You acknowledge that by your agreement to these terms and conditions, you:

- 1. are providing written instructions under the Fair Credit Reporting Act, and other applicable laws, including similar state laws, for United States Senate Federal Credit Union (USSFCU) to provide you with your FICO<sup>®</sup> Score and other information from your personal credit profile.
- 2. understand and authorize USSFCU to provide you with your FICO<sup>®</sup> Score based on Experian information on an ongoing basis.

I understand and authorize USSFCU to provide me with my FICO<sup>®</sup> Scores based on Experian information disclosed within my online account. I further understand that if I choose in the future to discontinue receiving my FICO<sup>®</sup> Scores, I can opt-out at any time by indicating this preference through my online account.

Viewing your FICO<sup>®</sup> Score will not affect your credit rating.

Only the primary member may authorize this request and only his/her FICO<sup>®</sup> Score is available through this program. USSFCU offers FICO<sup>®</sup> Score access at its own discretion. FICO<sup>®</sup> Score access is not a permanent feature of your account and may be removed at any time.

The FICO<sup>®</sup> Score provided is the FICO<sup>®</sup> Score 8 based on Experian data and may be different from other credit scores. Your FICO<sup>®</sup> Score falls into a range from 300 to 850, and is offered solely for your own non-commercial, personal review, and benefit. Your FICO<sup>®</sup> Score is not an endorsement or a determination of your qualification for a loan or credit.

FICO<sup>®</sup> and Experian are third-party providers and are not affiliated with USSFCU. USSFCU does not guarantee the accuracy of any credit information that is provided to you by these third parties.

FICO<sup>\*</sup> Score Summary is available within online banking at USSFCU provided you have enough credit history in a credit file with Experian to generate a credit score and score factors. If Experian cannot match you with a credit file or is otherwise unable to obtain your score, you will not be able to use this service until such time as you have built enough credit history. We reserve the right to refuse access to FICO<sup>\*</sup> Score Summary at any time.
